



## Contract

This contract is between Golden Beauty Kennels, LLC, a corporation registered in the State of Indiana, (breeder), hereinafter referred to as SELLER and \_\_\_\_\_, hereinafter referred to as BUYER.

Pursuant to the terms and conditions recited herein, Seller agrees to:

1. Sell to Buyer a puppy/dog identified as:

- 1) The Buyer agrees to pay the sum of \$ \_\_\_\_\_, and to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality food given at regular intervals, and fresh water available at all times. The Buyer agrees to provide a safe environment and to follow all applicable local, state, and federal laws which apply to the ownership, care, and custody of the animal which is the subject of this contract.
- 2) The Seller guarantees this puppy/dog to be of sound health and temperament at the time of this sale and to provide a health record of all shots and dewormings up to the time of sale.
- 3) The Buyer agrees to take this puppy/dog to a licensed veterinarian of their choice within 3 business days for a complete physical examination. Should the puppy/dog be determined to be in ill health, the cause of which is clearly attributable to the Seller, the dog may, upon signed written diagnosis

from said veterinarian, be returned for refund of the purchase price at no cost to the Buyer. If the puppy/dog is not taken to a licensed veterinarian within three business days of taking possession, the Seller's obligations contained herein are void. The Seller will assume no responsibility if this puppy/dog is given Ivermectin, Immodium or any other of the Golden Retriever sensitive drugs. This warranty does not include viral illnesses, infections, improper bites, stress-related illness, hernias, hypoglycemia, parasites (including Giardia or Coccidiosis), cancer or endocrine disorders, any illness due to the ingestion of foreign objects, food, or chemical, physical injury, hip dysplasia, undescended testicles, underbite or overbite, allergies, luxating patella, or collapsed trachea if not found on your veterinarian initial exam.

- 4) The Buyer agrees to finish all puppy vaccines before taking their puppy/dog out in public, letting their puppy on public sidewalks and grasses or letting their puppy be touched by people outside of the family. This reduces the chance of your puppy picking up a communicable disease such as Parvo WHICH CAN BE FATAL.
- 5) The Buyer agrees not to use this animal for breeding and agrees this Golden Retriever will be spayed/neutered. "Breeding" means A) Any act by Buyer that could result in an offspring of the animal which is the subject of this contract or B) Buyer failing to spay or neuter the puppy/dog at the earliest medically safe time.

Golden Retriever females should not be spayed until after their first heat cycle but before their 2nd heat cycle. Males should not be neutered until between 12 and 24 months. Medical exceptions can be made given veterinarian written explanation and agreement with Seller. As with any elective surgery, always consult your veterinarian.

This dog will be on limited AKC registration. A limited registration certifies that this animal is pure bred but must not be bred. Dogs registered under a limited registration may not be shown in confirmation but can be shown in obedience, performance, and other AKC competitive events. Any offspring resulting from a breeding of this animal will not qualify for any type of AKC registration.

Buyer must send proof of spay/neuter procedure to Seller via email within 10 days after said procedure.

Buyer agrees that any violation of this contract as outlined herein will terminate all of Seller's obligations herein and that Buyer is obligated to pay to Seller an amount fifteen times (1500%) the purchase price of the puppy, and Buyer will forfeit all income and any resulting puppies to Seller.

Buyer agrees that any legal fees incurred by the Seller to enforce this contract are the sole responsibility of the Buyer. Any and all legal proceedings will take place under the jurisdiction of Hamilton County, Indiana. Should an accidental breeding occur, Buyer must immediately notify Seller. In this case, no penalty fee will be charged to Buyer; however, Seller reserves the right to market and sell the resulting puppies and retain all profit associated with such.

- 6) If the Buyer can no longer retain possession of this puppy/dog, the Seller reserved the right to be notified and given first option of resuming full ownership of the puppy/dog. Refunds, if any, will be at the discretion of the Seller. The dog will be returned with all AKC papers and medical records. Should any circumstance arise that affects the quality of life of this dog, the Seller is to be informed. Under no circumstance will this puppy/dog be sold, leased, traded, or given away to any pet shop, research laboratory, animal shelter, or similar facility.
- 7) The Buyer agrees to contact the Seller with any questions/concerns that arise regarding, housing, diet, health, or training.

- 8) If AKC papers have not been furnished at the time of purchase, the Seller will provide Buyer with the registration papers at this agreed upon time:\_\_\_\_\_ . It is understood at the time of sale that this is a pet quality dog and it is representative of its breed. Training classes are recommended for a happy relationship between the dog and family.
- 9) The Buyer agrees to register the dog including the kennel name of Golden Beauty Kennels.
- 10) The parties herein agree that the above contract represents the entire agreement between the parties and that no other agreements exist between the parties, whether verbal or written.
- 11) The Buyer represents that they have read and understood the entire agreement herein, that they have had the opportunity to review the same with any other person of their choosing before entering into said agreement, that the agreement is fair and equitable, and that the consideration exchanged between the parties is reasonable.
- 12) The Buyer warrants that they have provided accurate contact information and social media account information to the Seller, that they, Buyer, will provide updates to said information in a timely manner to Seller so that both parties may continue to enforce the provisions of this agreement.
- 13) The Buyer agrees that their obligations contained herein have no expiration unless otherwise specifically stated herein.
